**॥ आम सूचना ॥**

सर्वसाधारण को सूचित किया जाता है कि सड़क परिवहन और राजमार्ग मंत्रालय, भारत सरकार के गजट संख्या-2841, दिनांक-28.08.2019 द्वारा मोटर यान (संशोधन) अधिनियम, 2019 के प्रावधानों को 01 सितम्बर 2019 से लागू करने का निर्णय लिया गया है, तदनुसार झारखण्ड राज्य में भी उल्लेखित प्रावधान लागू होंगे।

उक्त प्रावधानों में यातायात नियमों का उल्लंघन करने पर विभिन्न धाराओं के तहत दण्ड राशि में निम्न रूप से वृद्धि की गयी है :-
